



## TRIAL / TRYOUT PERMIT APPLICATION

**This form must be completed and submitted by the Club to the League 1 Ontario (L10) League Administrator.  
The Club will be notified by the League Administrator once the permit is validated.**

**PLEASE NOTE:**

- a) League1 Ontario does not allow players who are participating in trial/tryout activities with an L10 team solely via a Trial/Tryout Permit to be listed on the official game sheet for an official L10 Match. If an unregistered trialist participates in an official L10 match, they will be deemed ineligible, and the club shall face a penalty as per the L10 Discipline Code.
- b) The Trial/Tryout Permit shall be used by L10 teams to allow a player that is already registered with another club in the Ontario Soccer registration system for the 2023-24 Indoor Season or the 2024 Outdoor season to:
  - i. participate in Tryout/Trial/Training activities with the L10 team listed in Section C of this document, and/or
  - ii. participate in Exhibition (Friendly) Matches (with the L10 team listed in Section C of this document) that are not part of the official L10 schedule.
